Service effective period counted from first actual roaming data usage. When Europe 5/10-Day Pass is effective, a confirmation message will be sent via SMS.






Terms and Conditions:

- Europe 5-Day Pass, Europe 10-Day Pass ("Europe 5/10-Day Pass") are applicable only to (1) 3HK/ SUPREME
 postpaid customers who are qualified to subscribe roaming service; and (2) customers who use data roaming
 services in the designated destinations.
- 2. Roaming and IDD Service will be activated automatically upon activation of Europe 5/10-Day Pass. For details of Roaming and IDD Service, please visit www.supreme.vip for SUPREME.
- 3. When Europe 5/10-Day Pass is effective, a confirmation message will be sent via SMS.
- 4. Europe 5/10-Day Pass charge will be charged to your account with SUPREME immediately upon successful activation. It is chargeable on a 5 days or 10 days basis according to customer's selection and will not be prorated. The charge is non-refundable and regardless of usage.
- 5. Activated Europe 5/10-Day Pass needs to be used within 30 days from the day of successful activation ("Valid Period"). The service will expire upon the lapse of the Valid Period.
- 6. Subject to Paragraph 5 above and upon first use of roaming data("First Usage"), the activated Europe 5/10-Day Pass will be valid for a period of 5 days or 10 days (as the case may be). A "day" is counted by 24 hours after first roaming data usage. By way of example, Europe 5-Day Pass validity: If First Usage of the Europe 5-Day Pass at 3:00 pm (Hong Kong time) of 1st July, 2018, it will expire at 23:59 (Hong Kong time) of 6th July, 2018.
- 7. Upon expiry of Valid Period of the Europe 5/10-Day Pass, data roaming service will be restored to the data roaming plan currently subscribed-for by the customer prior to usage of the Europe 5/10-Day Pass (if any), or standard roaming service. For details of data roaming plans, please visit www.supreme.vip for SUPREME. Please login to MyAccount to obtain details about the current subscribed-for roaming plan (if any).
- 8. Customers who would like to continue to use Europe 5/10-Day Pass service have to activate again after the previous Europe 5/10-Day Pass expires.
- 9. Europe 5/10-Day Pass roaming voice calls included receiving calls, outgoing calls to local and Hong Kong. Calling to other countries will be charged at standard roaming rates. Please visit www.supreme.vip for SUPREME for coverage and charges.
- 10. In case that data usage incurred on non-Europe 5/10-Day Pass destinations, Customer will be charged at the rate of its subscribed in 3HK/ SUPREME applicable data service roaming plan; otherwise, Customer will be charged at the standard roaming charges. Please visit www.supreme.vip for SUPREME for coverage and charges.
- 11. Europe 5/10-Day Pass does not cover SMS, Home Direct Line service and video call, usage incurred on all networks will be charged at standard roaming rate. Voice call usage incurred on non-Europe 5/10-Day Pass networks will also be charged at standard roaming rate. Please visit www.supreme.vip for SUPREME for coverage and charges.
- 12. Europe 5/10-Day Pass shall not be applicable to usage on Peer to Peer ("PTP"). If usage is incurred due to PTP including applications such as (but not limited to) BitTorrent, edonkey, flashget, foxy, ppstream, winmx, etc, or if there is any abusive or abnormal usage, 3HK/ SUPREME shall have the right to forthwith terminate Europe 5/10-Day Pass without prior notice. All commercial or illegal promotion activities via the use of Europe 5/10-Day Pass shall be prohibited.
- 13. Europe 5/10-Day Pass shall not be applicable to aircraft roaming/maritime roaming/satellite roaming.
- 14. Europe 5/10-Day Pass only includes data transmission charges and does not include any other charges that might incur from using any other data service.
- 15. Tethering availability depends on network operators in the destinations. SUPREME does not restrict the use of tethering with Europe 5/10-Day Pass.
- 16. Usage of Europe 5/10-Day Pass is subject to the coverage, system compatibility and other relevant conditions of the networks, which are subject to changes without prior notice.
- 17. 4G LTE service will be available only when (i) compatible handset or device supporting 4G bandwidth is used and (ii) in the destinations where 4G LTE service infrastructure has been developed. 5G service will be available only when the customer (i) has subscribed to the applicable 5G serviced plan, (ii) compatible handset or device supporting 5G bandwidth is used and (iii) in the destinations where 5G service infrastructure has been developed.





18. SUPREME reserves the rights to amend the charges and terms and conditions (including but not limited to designated destinations coverage) of Europe 5/10-Day Pass and to suspend or terminate any part of the service at any time without prior notice, especially in case where roaming partner terminates cooperation with SUPREME. SUPREME shall have the final decision in case of any dispute.
