

## Terms & Conditions of Mainland China-HK-Macau 1-Card-Multi-Number (“This Service”)

1. This Service is jointly provided by Hutchison Telephone Company Limited ("3HK/ SUPREME "), China United Network Communications Corporation Limited ("China Unicom") and Hutchison Telephone (Macau) Company Limited ("3MO").
2. Hong Kong mobile number is the primary number. Mainland China mobile number and Macau mobile number are the secondary numbers.
3. To be eligible to subscribe to This Service, each customer will be required to subscribe to 3HK/ SUPREME 's IDD service and roaming service at the same time, and agrees that in addition to the terms and conditions stated herein the customer agrees to the general terms and conditions together with the special terms and conditions for roaming service of 3HK/ SUPREME (which terms and conditions shall be amended from time to time).
4. Customers who use data service under China Unicom's network in Beijing, Shanghai and Guangdong (including Shenzhen, Guangzhou, Fuoshan, Zhuhai, Shaoguan, Dongguan, Zhanjiang, Zhongshan, Zhaoqing, Huizhou, Shantou, Jiangmen, Shunde, Jieyang, Chaozhou, Meizhou, Qingyuan, Maoming, Yangjiang, Heyuan and Shanwei) (“Special Zones”) or in Macau under 3MO’s network will be charged at \$5/MB and will be billed on the basis of \$0.05/10KB. Customers who use data service under non-China Unicom's network in Mainland China may subscribe to "Data Roaming Daily Pass" service or may be charged at Standard roaming charges of 3HK/ SUPREME. 5. For SMS sending to 3HK/ SUPREME customers, intra-SMS fees will be deducted from the relevant basic monthly plans or (if necessary) the relevant customer will be required to pay surcharges for such intra-SMS. For SMS sending to non-3HK/ SUPREME customers, such SMS will be subject to inter-operators’ or international surcharges.
6. Each customer is required to use China Unicom's network in Special Zones and use 3MO's network in Macau in order to enjoy the special rates of This Service. Standard roaming charges of 3HK/ SUPREME apply for customers who do not conform to this requirement.
7. Each customer shall oblige by China Unicom's service terms and conditions while using This Service in China Unicom network and shall oblige by 3MO's service terms and conditions while using This Service in 3MO network. Such terms and conditions can be found on the respective websites of China Unicom and 3MO.
8. The monthly fee for This Service is calculated on a monthly basis, which follows the applicable billing cycle for the relevant individual. There is no pro-rata fee for the first and last months of the subscription period for the service.
9. The Mainland China secondary number is provided by China Unicom and the Macau secondary number is provided by 3MO, so that both numbers are not available for mobile number porting/change of consumership. If a customer terminates This Service, the customer is required to swap the special SIM for This Service to a standard 3HK/ SUPREME SIM in any designated 3Shop/ SUPREME SHOPS (whereupon the Mainland China and Macau secondary numbers will not be available for the customer’s use anymore).

10. 3HK/ SUPREME reserves the rights to amend the charges and terms and conditions (including but not limited to designated destinations coverage) of This Service and to suspend or terminate any part of the service at any time without prior notice, especially in case where roaming partner terminates cooperation with 3HK/ SUPREME. 3HK/ SUPREME shall have the final decision in case of any dispute.
