## Terms and Conditions

≤Local data included: 100GB basic data per month for Plan \$498

≥\$498 monthly fee Includes monthly 5,000 local voice (minutes) per month

1. Customer is required to subscribe to designated monthly plan, commit designated contract with designated prepayment amount (the prepayment amount will be credited to customer's billing account by Instalments during the contract period), pay for the first month's monthly fee and the Admin Fee of \$28 per month.
2. \$398 - \$418 monthly fee is net monthly fee after deducting Net Monthly Fee Rebate during contract period (\$98 - \$118) per month (the monthly rebate of \$18 will offset Admin Fee during the contract period) for designated handset model and designated Plan \$498.
3. Applicable during contract period.
4. This roaming data usage is applicable to the designated networks in Mainland China and Macau only. Roaming voice call, roaming SMS, Home Direct Line service and roaming video call are not included. Meanwhile, other SUPREME Services data roaming plan are not applicable to these destinations. 6. Prepayment of \$100 per SIM card fee is required for SIM subscription and shall be refunded after used for 1 month.
7. Customer is required to subscribe the add-on secondary SIM on the same day of monthly plan subscription with same contract commitment period.
