


新機王 HK\$2,000 早鳥優惠條款及細則

New/Existing customers ("Customers") who subscribe/renew/upgrade to the designated SUPREME 5G monthly plan ("Plan") in the period from 18 August 2023 till 14 September 2023, and make a prepayment of \$500 within 7 days from the plan subscribed / renewal / upgraded date by credit card to get the Early Bird Offer ("Offer") on the purchase of designated handset model of Master Handset Series ("Designated Handset"), will enjoy the following:
 - Entitle to a HK\$2,000 handset discount when purchasing a handset model of designated Master Handset Series (any model of the new Master Handset Series)
 - A guarantee to get the designated master handset within 7 days from the official open sales day.
- 2. Customers must be committed to at least a 24-month duration contract.
- 3. Customers must activate the account on or before 14 September 2023.
- 4. This offer excludes 5G Home Broadband Service plan, Staff Plan and Secondary SIM of Multi-SIM plan.
