Terms & Conditions of “Mainland China & HK 1-Card-2-Number” (“this Service”)

1. This Service is jointly provided by Hutchison Telephone Company Limited (“SUPREME”) and Mainland China United Network Communications Corporation Limited (“China Unicom”).
2. The Hong Kong mobile number is the primary number. The Mainland China mobile number is the secondary number. Each cardholder of a Hong Kong Identity Card and the Mainland Travel Permit for Hong Kong and Macau Residents under the same person can only apply for one Mainland China mobile number as the secondary number.
3. The “Mainland China & HK 1-Card-2-Number” service is available to existing customers who have been using SUPREME mobile phone postpaid services for two years or more.
4. Customers are required to provide original copies of their Hong Kong Identity Card and Mainland Travel Permit for Hong Kong and Macau Residents to complete the real-name registration process in order to use this Service. By applying for this Service, customers also consent to allow SUPREME to transfer and disclose their personal data to relevant telecommunications partners. If the personal data provided is incomplete or inaccurate, the registration process may not be finalized, and related services will be suspended accordingly.
5. To subscribe to this Service, customers must have an approved credit card autopay set up to authorize SUPREME to automatically deduct the monthly service fee from the registered credit card account.
6. When customer is located in Mainland China i) the secondary number* will be shown when making calls to any country; and ii) the secondary number* will be shown when sending SMS to Mainland China phone numbers; while primary number* will be shown when sending SMS to phone numbers of countries other than Mainland China.
*Subject to the supporting service scope and coverage which can actually been provided by the relevant roaming partner of SUPREME (including but not limited to China Unicom) at each of the roaming areas.
7. To be eligible to subscribe for this Service, each customer will be required to subscribe for SUPREME's IDD service and roaming service at the same time, and agrees that in addition to the terms and conditions stated herein the customer agrees to the general terms and conditions together with the special terms and conditions for roaming service of SUPREME (which terms and conditions shall be amended from time to time).
8. Customers who use data service in Mainland China will be charged based on their subscribed roaming service. Customers who did not subscribe to any roaming services will be charged at standard roaming charges.
9. For SMS sending to SUPREME customers, intra-SMS fees will be deducted from the relevant basic monthly plans, or (if necessary) the relevant customer will be required to pay surcharges for such intra-SMS. For SMS sending to non-SUPREME customers, such SMS will be subject to inter-operators’ or international surcharges.
10. Customer is required to be located in Mainland China and connect to China Unicom's mobile network in order to enjoy the special rates of this Service. Standard roaming charges of SUPREME will apply to

customers who do not conform to this requirement.

11. The monthly fee for this Service is calculated on a monthly basis, which follows the applicable billing cycle for the relevant mobile plan. There is no pro rata fee for the first and last months of the subscription period for this Service.
12. Unless otherwise stated above as special rates or charges for this Service, all other services will be subject to the charges under the basic monthly plan as subscribed by the relevant subscriber and/or the standard roaming charges of SUPREME.
13. The secondary number is provided by China Unicom and is not available for mobile number porting. If a customer terminates this Service, the customer is required to swap the special SIM for this Service to a standard SUPREME SIM in any designated SUPREME SHOPS (whereupon the secondary number will not be available for the customer's use anymore).
14. SUPREME reserves the rights to amend the charges and terms and conditions (including but not limited to designated destinations coverage) of this Service and to suspend or terminate any part of this Service at any time without prior notice, especially in case where roaming partner terminates cooperation with SUPREME. SUPREME shall have the final decision in case of any dispute.
15. Should there be any question regarding the terms and conditions as stated above, please contact our SUPREME SHOPS assistants for enquiry.
16. Should there be any inconsistencies between the Chinese and English versions of these terms and conditions, the English version will prevail.
17. These terms and conditions of this Service are governed by the laws of Hong Kong.
